PURPOSE: TO LIMIT LOCATIONS THAT SMOKE SHOPS CAN OPERATE

A vote in favor of this article will prohibit Smoke Shops from all Zoning Districts and Overlays **EXCEPT** by Special Permit in the Continuous Traffic Business (BT) Zoning District.

- 3. 66 Middlesex Turnpike Midas

ARTICLE#14: SMOKE SHOP AMENDMENT

Create a new definition of "Smoke Shop" under Article II: Definitions

2.19

<u>Smoke shop</u> An establishment whose principal use is dedicated to the display, sale, distribution, delivery, offering, furnishing, or marketing of tobacco, tobacco products, or tobacco paraphernalia, electronic tobacco as a <u>principal use</u>. Any grocery store, supermarket, convenience store or similar retail use that sells tobacco products, but where tobacco is not the principal use, shall not be included within the definition of Smoke Shop. Smoke shops are not Registered Marijuana Dispensaries (RMD).
